- e) STP/BR No Action. Manager reported the STP District 5 allocation amounts is listed in their packet. She reported none of the individual counties' used their portion before December 2018, therefore, the funds have moved to the District 5 Board's control. She reported that OK has 2 projects and McClain has 1 project ready for the District Funds. The Manager stated funding must be allocated by the May Meeting but wanted to remind the Members to get any possible projects ready and ODOT cleared by the end of April for the use of the \$1,632,936.98 available. She informed the new commissioners, after the funds are in the Board's control, their resolution states the 1st project for each member county is made available before funds are made available for any county's second projects will be considered.
- f) STP/RD -No Action. The manager explained, the Board's Resolution (see Resolution included backup document folder) states the funds will go to one county using the "Round Robin" method. Meaning that the member county's basically take turns. Right now the projects continue as planned by the previous ACCO Plans until 2021.

Subject: week 3 update

POLITICS:

Governor Stitt had his first Board of Equalization meeting this past week. The fiscal year for 2020 general revenue estimate came in at \$574.5 million above last year's budget - so lawmakers will have

\$574 million more to appropriate. However the Governor's focus is on improving our state's savings and delivering agency accountability. Finance Secretary, Mike Mazzei, also commented that "we need to be cautious when allocating agency appropriations this year - over the next two years we must build a sustainable state budget." So we will see if the state budget inflates or stays flat.

The Governor would like to set aside \$200 million for savings. He also plans to take the \$30 million that the State Health Dept. has been holding on to and place \$5 million in a "Quick Action Closing Fund" and the balance would pay for agency performance audits.

The House and Senate plan to give an additional pay increase to each teacher in the amount of \$1200. The House Democrats believe every dollar of additional revenue should be put back into state agencies that have been raided over the years.

PROCESS:

Senate and House JCAB (Joint Committee on Appropriations & Budget) are already meeting and passing bills. The Senate Appropriation Committee has already passed a House Bill. This is unusual since they have not yet completed their own committee work. Guess which one?

Yep! HB2597 that is referred to as the "Constitutional Carry" – this bill will allow people to carry a weapon without a permit or training. Senate Appropriations committee passed it by a vote of 18-4. It now goes to the Senate floor for final passage.

In other news, The House Rules committee took action on the HB2612 by Echols, referred to as the "Unity Bill." This bill is nearly 80 pages in length to provide the legislature with a framework to pass laws and regulations to further implement SQ788, the Medical Marijuana Act. The State Health Department will oversee the regulation and has projected the first year of implementation would cost \$9.8 million.
